Fee Policy (Annual Season Base Fees include):

- registration fee (1st month)
- monthly class fee (core/improvisation [9 installments])
- costumes (3 installments)

Class Fee Rates

(Minimum Seasonal Base Fee: \$500 • Effective May 24, 2011)

- \$50-Registration Fee** (Annual)
- \$50-Monthly Core Class Fee** (9 installments [**Ballet & Tap**])*
- \$10- Monthly Improvisational Class Fee** (Each Class-9 installments [**Jazz, Hip-Hop, Lyrical**])*

Seasonal Class Fees might be higher due to additional classes taken by participant

Registration Fee required for participants, due upon registration and is non-refundable.

Monthly Class Fees required for participants and may be paid in 9 installments. Monthly Class Fees are due the 2nd Wednesday of each month and includes class instruction, recital rehearsal/performances and awards' ceremony. Final Class Fee payment (June 2012 payment) is due the 4th Wednesday of May 2012. Monthly Class Fees are non-refundable.

Costume Fee Rates

(Minimum Costume Fee: \$50 • Effective May 24, 2011)

- \$50-Core Costume Fee** (Ballet, Tap [1st & 2nd])
- \$40-3rd Costume Fee** (Jazz, Hip-Hop, Lyrical)
- \$30-4th Costume Fee** (Jazz, Hip-Hop, Lyrical)
- \$20-Costume Material Fee** (per costume over Adult Large Sizing)

Costume Fees might be higher due to additional costumes and/or costume material fee

Costume Fees are based on classes taken by each participant. Core Costume Fees (1st and 2nd costumes) are \$50 with the 3rd costume fee of \$40 and the 4th costume fee of \$30. All costume fees will be tallied into 3 installments due on October 15, 2011, December 10, 2011 and February 10, 2012. For costumes larger than an adult large, a \$20 costume material fee per costume will be incorporated into Costume Fees Installments per costume. Costume Fees are non-refundable.

Competition Fee Rates

(Minimum Competition Instructional Fee: \$90 • Effective May 24, 2011)

- \$5-group competition instructional fee** (9 installments)
- \$7-trio competition instructional fee** (9 installments)
- \$10-Soloist competition instructional fee** (9 installments)

All students interested in competing for 2011-2012 Season must audition **no exceptions**. Auditions will take place in August 2011. If selected, additional practice days/times will be determined by instructor. Above-stated fees will be due in 9 monthly installments starting in September 2011 and are due the 2nd Wednesday of each month. Competition Instructional Fees are non-refundable.

Certain fund-raising will be available to assist families with fees; **THESE FUND-RAISERS ARE NOT MANDATORY OR REQUIRED**. Upon request by parent, a fund-raising credit will be issued upon completing of each fund-raiser with the credited amount (profit margin) being deducted from Class Fees, Costumes Fees and/or Competition Instructional Fees; regardless of fund-raising participation, parents are responsible to cover all fees.

To assist in organizational operational cost and to keep participant fees low, we host one (1) **MANDATORY ANNUAL FUND-RAISER (Souvenir Book Ad)**. We request that each child sells at least \$200 worth of ads annually. **If you chose not to participate in this mandatory fund-raiser**, the difference will be added to seasonal fees divided into 9 monthly installments (\$20 average maximum [decision must be determined at registration]).

Annual discounts provided to siblings (same household), members of Calvary Presbyterian Church and other area Presbyterian Churches. **2011-12 Season Specials Offered:** 2 for the Price of 1, Buy One Get One ½ Off, Early Bird, Welcome Back, Longevity and others; costume fees and competition instruction fees are not included in specials, discounts and bonuses offered.
